Frisco ISD Puts Student Safety First With OxySure® Emergency Oxygen

The Fisd school board decided in February to approve the purchase and installation of OxySure units and Display Wall-boxes for all elementary, middle and high schools. In addition, OxySure units with protective Thermal Bags were approved for athletic trainers, field trips and other off campus activities.

“It was an easy decision for us”, says Doug Zambiasi, Assistant Superintendant for Administrative Services. “Once we looked at the technology and understood that, safe, easy-to-use, life-saving oxygen without a prescription was available, we did not hesitate.”

The OxySure Model 615 units will be installed in OxySure Display Wall-boxes throughout the existing schools and administration buildings as well as all the new buildings coming online, right next to every Automated External Defibrillator (AED) in the district. “We want to be proactive in providing available resources to keep our students, staff and visitors safe. Adopting this amazing, break-through technology aligns with our desire to be leading edge in matters of safety,” Zambiasi said.

The National Association of School Nurses (NASN) has issued a policy statement indicating that the majority of sudden death in children occurs from respiratory arrest, not cardiac arrest. Kathy Tolbert, Health Services Lead Nurse agrees with that policy statement, “I know that having OxySure by my side gives me another vital tool to do my job, which is to take care of my kids. Parents entrust their kids to us every day and we take our charge seriously. Having this available is extremely beneficial and I’m thankful that the school district said yes to this technology.”
